At the end of October 2021, the NERHCC spent \$14,495.69 (or 20%) of what was budgeted for the second quarter and 20% of the entire PO amount to-date (\$51,388.97). Because producing the Integrated Preparedness Planning Workshop cost less than anticipated, Regional Projects is the highest priority expenditure category to spend down during November and December, with a total of \$29,809.85 budget remaining for the quarter. Of the Regional Projects budget remaining in quarter 2, the largest line item is Regional Projects that Meet Scope and Criteria with \$16,162.92 budget remaining (54% of total budget remaining in quarter 2 for Regional Projects).
